

Participant Declaration / Informed Consent - Rage District B.V.

Private limited liability company **Rage District B.V.** (hereinafter: **Rage District**) is registered with the Dutch Chamber of Commerce under number **99820544**, with its registered office at **Elementenstraat 10, 1014 AR Amsterdam, the Netherlands**.

This participant declaration applies to every Participant in an Activity offered by Rage District. The purpose of this document is to clearly inform the Participant, prior to participation, about the nature of the Activity, the risks associated with it, the applicable safety conditions and the personal declarations that Rage District may reasonably require from the Participant.

By signing this document, the Participant declares that they have read this participant declaration in full, understood it and completed it truthfully.

1. Declaration of age and identity

1. I declare that I am **18 years of age or older** on the date of participation.
2. I understand that participation in an Activity of Rage District is only permitted for persons aged 18 or over.
3. I understand that Rage District may request me to present a valid identity document and that participation may be refused if my age or identity cannot be adequately established.

2. Information about the nature of the activity and acknowledgment of risk

1. I understand that participation in an Activity of Rage District takes place in an environment in which objects are destroyed, dismantled or otherwise handled in a controlled manner with the use of tools and impact instruments.
2. I understand that, despite safety measures, supervision and instructions, inherent risks are associated with this Activity.
3. I understand that these risks may include, but are not limited to:
 - a. flying or falling pieces of glass, ceramics, metal, plastic or other materials;
 - b. sharp edges, splinters, dust, noise and physical strain;
 - c. injury as a result of incorrect or careless use of tools or impact instruments;
 - d. injury resulting from my own actions, the actions of fellow Participants or the failure to comply with instructions and safety rules.
4. I declare that I understand the nature of the Activity, that I am aware of the risks associated with it and that I participate voluntarily.

3. Health, physical and mental fitness

1. I declare that, in my own judgment, I am physically and mentally fit to participate in the Activity safely.
2. I declare that I do not suffer from any physical, psychological or other medical condition that makes participation unsafe or that could be aggravated by participation, unless I have fully informed Rage District thereof prior to participation and Rage District has nevertheless expressly allowed my participation.
3. I declare that I am not under the influence of alcohol, drugs, narcotic substances or medication that may adversely affect my reaction time, judgment, coordination or safety awareness.
4. I understand that Rage District does not provide medical advice and that the assessment of whether participation is responsible is, in principle, my own responsibility, without prejudice to Rage District's right to refuse or terminate participation on safety grounds.
5. I understand that participation in the Activity does not constitute medical or psychological treatment and is not a substitute for professional care or therapy.

4. Safety rules and rules of conduct

1. I undertake to follow immediately, fully and strictly all safety instructions, house rules and directions given by or on behalf of Rage District.
2. I understand that I may only participate in the Activity if and for as long as I properly wear and use all protective equipment made mandatory by Rage District.
3. I understand that closed and sturdy shoes are mandatory and that Rage District may impose additional requirements regarding clothing, protective equipment and conduct.
4. I shall only use tools, materials and facilities authorised by Rage District and only in the manner prescribed by Rage District.

5. I shall not bring or use my own tools, weapons, liquids, flammable substances, explosive substances, narcotic substances or other dangerous or unauthorised items, unless Rage District has expressly granted prior permission.
6. I shall conduct myself in such a way that the safety of myself, other Participants, staff, bystanders and the property of Rage District or third parties is not endangered.
7. I understand that Rage District may apply additional practical safety rules, including rules concerning keeping distance, simultaneous use of impact instruments, waiting directions, demarcated zones and entering or leaving the room.

5. Refusal of participation and termination of the activity

1. I understand that Rage District is entitled to refuse, interrupt or immediately terminate my participation if, in Rage District's opinion, there is a safety risk or if I act in breach of this participant declaration, the house rules or staff instructions.
2. I understand that this may in any event be the case if:
 - a. I have provided inaccurate or incomplete information;
 - b. I appear to be, or are suspected of being, under the influence;
 - c. I behave in an aggressive, reckless, intimidating, disruptive or otherwise unacceptable manner; or
 - d. I fail to comply with safety instructions or staff directions.
3. I understand that, in such case, Rage District is not obliged to provide a refund unless mandatory law provides otherwise.

6. Damage, liability and personal responsibility

1. I understand that Rage District does not exclude liability for damage insofar as exclusion or limitation is not permitted under mandatory law.
2. I further understand that, when liability is assessed, relevance may be attached to whether I have complied with the applicable safety rules, provided accurate and complete information and conducted myself in a manner consistent with the nature of the Activity.
3. I accept that damage partly caused by my own acts or omissions, including failure to follow instructions, provision of inaccurate or incomplete information, unsafe conduct or participation while I was not fit to do so, may remain at my own risk and expense or may lead to a reduction of any obligation of Rage District to pay compensation, insofar as the law permits.
4. I am liable for damage to property belonging to Rage District or to third parties if such damage results from my conduct contrary to instructions, safety rules, the nature of the Activity or the arrangements made with Rage District.
5. I understand that I remain personally responsible for my clothing, jewellery, telephone, glasses, cash and other personal belongings brought to the Location.

7. Personal data, CCTV and image material

1. I understand that Rage District processes my personal data for purposes connected with my participation in the Activity and the performance of the Agreement, in accordance with applicable data protection law.
2. I understand that CCTV may be in operation at and around the Location for the purposes of safety, supervision, incident registration and the protection of persons and property.
3. I understand that any use of image material for promotional or commercial purposes shall only take place where there is an adequate legal basis for doing so.
4. Insofar as Rage District expressly requests my consent for the use of recognisable image material for promotional purposes, I may indicate my choice below:
